
## **INVESTMENT OBJECTIVE**

The primary objective of the Quantum BCI Capital Plus Fund of Funds is to achieve longterm income returns.

# **INVESTMENT POLICY**

Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, investing in amongst others, equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities. To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value.


